WE, the undersigned owners of units in Adena Knolls Condominium -- Phase 1-A, and in the aggregate totaling one hundred percent (100%) of the voting power of the Adena Knolls Condominium Association, do hereby consent that the following action be taken without a meeting and the following resolution is hereby adopted this 26th day of October, 1988, to be effective immediately as of the filing of Amendment No. 1 to the Declaration of Condominium Ownership.

BE IT RESOLVED, that the Bylaws of the Declaration, are hereby modified and supplemented by substituting the following Paragraph 6.02 for the one in the original filing of the Declaration:

ADENA KNOLLS BYLAWS

6.02 No Active Business to be Conducted for Profit

Nothing herein contained shall be construed to give the Association authority to conduct an active business for profit on behalf of all the Owners or any of them. Notwithstanding the foregoing, the Association shall make the Adena Knolls swimming pool and its auxiliary facilities available for use by all Owners of North Pointe Condominiums on a voluntary basis; and the Association may make the Adena Knolls swimming pool and its auxiliary facilities available for use by owners and residents in Heritage Woods Allotment, in any number deemed appropriate by the Board, on an annual voluntary first-come, first-served basis (which shall be renewable only in the Board's sole discretion). The Association may charge for this privilege an amount the Association feels sufficient to cover the cost and privilege of such use. The amount so charged may equal or exceed the average budgeted pool maintenance fee in the Adena Knolls Condominium budget, but in no event shall the amount charged to a participating North Pointe Condominium Owner or Heritage Woods Allotment owner or resident be less than the average per unit budgeted amount charge in seasonal, annual, or monthly amounts, as it sees fit. Any participating North Pointe Owner or Heritage Woods Allotment owner or resident must agree to abide by such rules and regulations as set forth by the Adena Knolls Condominium Association.
