THIRD AMENDMENT TO THE

DECLARATION OF CONDOMINIUM OWNERSHIP

FOR WHISPERING PINES CONDOMINIUM

This Third Amendment to the Declaration of Condominium Ownership for Whispering Pines Condominium is made on or as of October 9, 2009, 2009, pursuant to provisions of Chapter 5311 of the Revised Code of Ohio.

WITNESSETH

Now come the duly authorized officers of the Whispering Pines Condominium Association of Dover created pursuant to the provisions of Chapter 5311 of the Revised Coded of Ohio as the unit owners' association for the Whispering Pines Condominium who do hereby submit the following Third Amendment to the Declaration of Condominium Ownership for Whispering Pines Condominium and who do hereby upon their own personal knowledge and information certify that this Third Amendment has been duly enacted in accordance with the provision of Article XVIII of the Declaration of Condominium Ownership for Whispering Pines Condominium.

WHEREAS, on September 14, 2000, Mark Benes Quality Homes & Remodeling Co. filed that certain Declaration of Covenants, Conditions and Restrictions (the "Declaration") for the Whispering Pines Condominiums, recorded in Volume 762, Page 866 of the Tuscarawas County, Ohio Deed Records (the "Declaration"); and

WHEREAS, the Declaration may be amended in accordance with Article XVIII; and

WHEREAS, the First Amendment to the Declaration was filed on January 28, 2003, and,

WHEREAS, a Second Amendment (described as "AMENDMENT CHANGE") was filed on December 22, 2003; and,

WHEREAS, the Unit Owners have met all requirements for an amendment of this nature;

NOW THEREFORE, pursuant to the powers set forth in Article XVIII, the Declaration is hereby amended as follows:

Article III, Section 2 (1) Animals. Except as provided in this paragraph,

no animals, livestock or poultry of any kind shall be raised, bred or kept in any Unit or on the Common Areas. Notwithstanding the forgoing, one domestic household pet, not bred or maintained for commercial purposes, may be maintained in a Unit, provided that: (i) no animal shall be permitted in any portion of the Common Areas except on a leash maintained by a responsible person; (ii) the permitting of animals on the Common Areas shall be subject to such rules and regulations as the Board may from time to time promulgate, including, without limitation, the right to place limitations on the size, and type of such pet, and the right to levy fines and enforce charges against persons who do not clean up after their pet; and (iii) the right of an Occupant to maintain an animal in a Unit shall be subject to termination if the unit owner has, on three or more occasions, failed to clean up after their pet, or if the Board, in its full and complete discretion, determines that maintenance of the animal constitutes a nuisance or creates a detrimental effect on the Condominium or other Units or Occupants.
