WHEREAS, a certain Third Amendment to Declaration of Condominium Ownership for Carlton House Condominium ("Third Amendment") was filed in the Recorder's Office of Summit County, Ohio on August 23, 2001 and duly recorded as Reception No. 54587730; and

1. Item 19 of the Declaration on pages 23 through 28 is replaced by the following:

### 19. Sale, Lease, Rental or Other Disposition.

- A. Owner's Right of Transfer. The Association shall have no right of first refusal with respect to the purchase or lease of a Family Unit, and an Owner shall be able to transfer his or her Family Unit freely by sale, gift, devise, lease or otherwise without restriction except as provided in Item 3 (as amended by the Third Amendment).
- B. Names of Owners and Occupants of Family Units. To enable the Association to maintain accurate records of the names, addresses and phone numbers of Owners and other Occupants of Family Units, each Owner agrees to notify the Association in writing, within five (5) days after such Owner's Family Unit has been transferred or leased to another person. In addition, each Owner agrees to provide to a Purchaser or lessee of such Family Unit a copy of this Declaration (including amendments thereto), the Bylaws (including amendments thereto), the Rules and other relevant documents.


